- All monthly Sign Up calendars and full tuition payment are due by the 25<sup>th</sup> of each month for the following month (i.e. Calendar and tuition is due on October 25<sup>th</sup> for the month of November).
- A late payment fee of \$10.00 will be assessed if the sign up calendar and full payment is not received by the 25<sup>th</sup> of each month.
- Checks that are returned from the bank for any reason will be charged a processing fee of \$40.00. The outstanding balance must be paid in full before the child may return to the program.
- A child may be suspended from the program if program fees are not paid in full.
- Children not picked up by closing time (6:00pm) will be assessed a Late Pick-up fee of \$5.00 for the first 15 minutes of tardiness and \$1.00 per minute thereafter. A child may be suspended from the program if he/she is continuously picked up late.
- If a child is going to be absent from Kruzin Krew, the Community Center must be emailed at <a href="mailto:absence@rfcc.info">absence@rfcc.info</a> or phoned at (708) 771-6159 by 9:00 am on the day of the absence.
- I understand that if someone other than myself or other person(s) designated on the enrollment form will be picking up my child, the Community Center must be notified prior to my child being picked up.
